**ORDER No. 2013-024**

**AN ORDER PROVIDING FOR THE TRANSFER OF CDBG FUNDS**

WHEREAS, under Local Government Fiscal Responsibility Act, Act 72, Public Acts of Michigan, 1990, as amended ("Act 72") and as superseded by the Local Financial Stability and Choice Act, Act 436, Public Acts of Michigan, 2012 ("Act 436"), as well as any successor Acts, and a Contract (the "Contract") dated October 25, 2012 between the State of Michigan and Joyce A. Parker, Joyce A. Parker has been appointed as the Emergency Manager (the "EM") of the City of Allen Park, County of Wayne, Michigan (the "City") and is thereby charged with the power and authority to take all actions necessary to develop and implement financial and operational plans, to regulate expenditures, investments, ensure compliance with federal, state and local laws, regulations, rules, local laws and make provisions for services essential to the public health, safety, and welfare of the City of Allen Park, including the power to exercise the authority and responsibilities of the Mayor, the Chief Administrative Officer of the City, and of the City Council, as the governing body of the City, concerning the adoption and enforcement of ordinances and resolutions affecting the financial condition of the City as provided in the Home Rule City Act, Act 279, Public Acts of Michigan, 1909, as amended ("Act 279"); and

WHEREAS, pursuant to Act 436 and specifically MCL 141.1552(1)(dd) and (ee) an emergency manager has the power and authority to exercise, on behalf of the local government, all authority and responsibilities of the governing body including enforcement of ordinances and resolutions as provided under the Home Rule City Act, 1909 PA 279, and take any other action or exercise any power or authority of any officer, employee, board, and commission, recognizing that the power of the emergency manager shall be superior to and supersede the power of any of the aforementioned officers or entities;

WHEREAS, pursuant to the Community Development Block Grant (CDBG) requirements and regulations for the appropriate transfer of CDBG programming dollars, the City of Allen Park held a properly noticed Public Hearing for the transfer of funds on September 10, 2013, at 6:00pm. Additionally, the public hearing sought comment on the proposed transfer of PY 2010 CDBG Funds of approximately \$25,840.00 from Senior Services and approximately \$13,600.00 from Administration for a total of \$39,440.00 proposed for transfer to Housing Rehabilitation Multi Unit Residential for the purpose of completing eligible projects at the Leo Paluch Senior Housing Facility;


WHEREAS, this ORDER is necessary in order to carry out the duties and responsibilities required of the Emergency Manager as set forth in Public Act 436, the Contract and the emergency financial plan;

**RESOLVED, NOW THEREFORE, IT IS HEREBY ORDERED BY THE EMERGENCY MANAGER OF THE CITY OF ALLEN PARK, PURSUANT TO PUBLIC ACT 436 OF 2013, THE CONTRACT, AND ALL OTHER RELEVANT LEGAL MANDATES THAT:**

1) The City of Allen Park Transfers Community Development Block Grant (CDBG) funds of approximately \$39,440.00 from PY 2010 Senior Services (\$25,840.00) and Administration (\$13,600.00) to a new activity, Housing Rehabilitation – Multi-Unit Residential (\$39,440.00) for the purpose of completing eligible projects at the Leo Paluch Senior Housing Facility.

2) Repeal. All ORDERS of the Emergency Manager, resolutions of the Allen Park City Council and parts of resolutions, orders or contracts in conflict with this ORDER are hereby repealed to the extent of such conflict.
