ORDER OF THE EMERGENCY MANAGER OF THE CITY OF ALLEN PARK, COUNTY OF WAYNE, STATE OF MICHIGAN, RATIFYING, CONFIRMING AND APPROVING ORDERS AND ACTIONS TAKEN PURSUANT TO THE FORMER LOCAL GOVERNMENT FISCAL RESPONSIBILITY ACT, ACT 72, PUBLIC ACTS OF MICHIGAN, 1990, AS AMENDED.

WHEREAS, the City of Allen Park (the "City"), a municipal corporation of the State of Michigan (the "State"), has been duly created under the provisions of the Home Rule City Act of the State, Act 279, Public Acts of 1909, as amended ("Act 279"), pursuant to which the City has the comprehensive home rule power conferred upon it by Act 279 and the Constitution of the State of 1963 (the "Constitution"), subject only to the limitations on the exercise of that power contained in the Constitution, by statute of the State or by provisions of the City Charter of the City; and

WHEREAS, under the former Local Government Fiscal Responsibility Act, Act 72, Public Acts of Michigan, 1990, as amended ("Act 72") and a Contract (the "Contract") between the State and Joyce A. Parker, effective October 29, 2012, Joyce A. Parker was appointed as the emergency financial manager of the City; and

WHEREAS, Act 72 was repealed by the Local Financial Stability and Choice Act, Act 436, Public Acts of Michigan, 2013 ("Act 436"), which became effective on the date hereof; and

WHEREAS, pursuant to Section 9(10) of Act 436, an emergency financial manager appointed under former Act 72 and serving immediately prior to the effective date of Act 436 shall be considered an emergency manager under Act 436 and shall continue under Act 436 to fulfill his or her powers and duties, and effective on the date hereof, Joyce A. Parker became, *ipso facto*, the emergency manager of the City under Act 436 (the "Emergency Manager"); and

WHEREAS, the Emergency Manager desires to ratify, confirm and approve all orders issued and all actions taken by her in her capacity as emergency financial manager of the City pursuant to Act 72.

NOW, THEREFORE, BE IT ORDERED by the Emergency Manager of the City as follows:

1. All orders issued and all actions taken by the Emergency Manager in her capacity as emergency financial manager of the City pursuant to Act 72 are hereby ratified, confirmed and approved.
2. This Order shall be effective immediately upon its execution by the Emergency Manager.
