

**Emergency Manager of the City of Allen Park
Order No. 2014-055-8 AMENDED**

ORDER OF THE EMERGENCY MANAGER OF THE CITY OF ALLEN PARK, COUNTY OF WAYNE, STATE OF MICHIGAN, MAKING APPOINTMENTS PURSUANT TO THE DISCLOSURE POLICIES AND PROCEDURES FOR MUNICIPAL BONDS OF THE CITY OF ALLEN PARK

WHEREAS, under the Local Government Fiscal Responsibility Act, Act 72, Public Acts of Michigan, 1990, as superseded by the Local Financial Stability and Choice Act, Act 436, Public Acts of Michigan, 2012 (“Act 436”), and a Contract (the “Contract”) dated October 25, 2012 between the State of Michigan and Joyce A. Parker, Joyce A. Parker has been appointed as the Emergency Manager (the “EM”) of the City of Allen Park, County of Wayne, Michigan (the “City”); and

WHEREAS, pursuant to Order No. 2014-055 of the EM, the EM has adopted written Disclosure Policies and Procedures for Municipal Bonds of the City of Allen Park, which require the EM to formally appoint, by order of the EM: (A) one City official to act as the City’s authorized spokesperson for external communications that foreseeably could affect a reasonable investor’s decision whether or not to buy or sell any bonds, notes or other securities of the City (the “Authorized External Spokesperson”); (B) a second person to act as the City’s alternate authorized spokesperson for such purposes in case of the authorize spokesperson’s absence or unavailability (the “Alternate Authorized Spokesperson”); and (C) one leader and two additional members of a 3-person disclosure working group named the Disclosure Team.

NOW THEREFORE, BE IT ORDERED BY THE EMERGENCY MANAGER OF THE CITY OF ALLEN PARK, PURSUANT TO ACT 436, AND THE CONTRACT, THAT:

1. Effective immediately, the Emergency Manager makes the following appointments pursuant to the Disclosure Policies and Procedures for Municipal Bonds of the City of Allen Park:
