WINTER TAX BILL COVERS THE PERIOD
DECEMBER 1, 2021 THROUGH NOVEMBER 30, 2022

PAYABLE BY FEBRUARY 14TH
BEGINNING FEBRUARY 15TH, A LATE PENALTY OF 3% WILL BE ASSESSED

FEBRUARY 28TH - LAST DAY TO PAY TAXES AT CITY HALL
