**PROPOSED ORDINANCE #02-2019**

**AN ORDINANCE OF THE CITY OF ALLEN PARK CODE OF ORDINANCES; AMENDING CHAPTER 2, “ADMINISTRATION”, ARTICLE V, “BOARDS, COMMISSIONS, COMMITTEES AND AUTHORITIES”, DIVISION 10 “HISTORICAL COMMISSION”, BY THE REPEAL AND READOPTION OF SECTIONS 2-542, 2-543, AND 2-546, TO UPDATE THE DIVISION.**

**The City of Allen Park Ordains:**

**SECTION 1. Amendment to Code.**

Chapter 2, Administration  
Article V, Boards, Commissions, Committees and Authorities  
Division 10. Historical Commission

That Sections 2-542, 2-543, and 2-546 are hereby repealed and readopted to hereinafter read as follows:

**Sec. 2-542. - Term of members; compensation of members; removal of members; vacancies.**

(a) The appointed members of the historical commission shall serve for a term of five years. The initial appointments to the commission shall serve terms as follows:

- (1) Two members for a term of five years;
- (2) Two members for a term of four years;
- (3) Two members for a term of three years; and
- (4) Two members for two years.

Thereafter, all new appointments shall be for five years. Vacancies occurring on the commission before the expiration of any term shall be reported to the mayor and council and shall be filled by appointment for the unexpired term. All members shall serve as such without compensation. Any member may be removed by the council for failure to attend three consecutive regular meetings, or 25% of such meetings in any fiscal year unless such absence shall be excused by the commission, or for inattention to duties.

(b) In the event of death, resignation or removal of any member, the successor shall be appointed to serve for the unexpired term for which such member had been appointed in the manner heretofore described. However, all members shall continue in office until their successor shall have been appointed.

**Sec. 2-543. - Organization; meetings.**

The historical commission shall organize by annually electing a chairperson, a vice-chairperson, a secretary, a treasurer and such other officers as may be deemed necessary from its membership and shall adopt its own rules of procedure and shall hold such meetings, either regular or special, as it shall deem necessary to carry on its work.

**Sec. 2-546. - Officers.**

The historical commission may appoint officers as described in Section 2-543 and prescribe the duties thereof.
